

**Decree No.: 2022/017**

**Decree on mooring prohibition for river cruise berths 4, 5 and 6 located at Ruijterkade Oost**

The Director of the Central Nautical Management North Sea Canal Area

**Having regard to:**

- Article 1.1 of the Regional Port Bye-laws for the North Sea Canal Area 2019;
- Article 3.1 of the Regional Port Bye-laws for the North Sea Canal Area 2019, on the grounds of which the Mayor and Aldermen may place road signs listed in the Binnenvaartpolitierglement (BPR / Inland Navigation Police Regulations) and may add further indications to such road signs;
- Article 3.2 of the Regional Port Bye-laws for the North Sea Canal Area 2019, on the grounds of which the Mayor and Aldermen may designate areas which the presence or berthing of certain categories of ships are prohibited;
- The Mandate, Power of Attorney, and Authorization Decree, dated 3 December 2019, published on 3 January 2020, on the basis of which the Director of the Central Nautical Management North Sea Canal Area is mandated to adopt Decrees on behalf of the Mayor and Aldermen of the municipality of Amsterdam.

**Having considered that:**

- The Director of the Central Nautical Management North Sea Canal Area, on behalf of the Mayor and Aldermen of Amsterdam, may designate areas or berths in which mooring is prohibited;
- river cruise berths 5 and 6 located at De Ruijterkade Oost are no longer available for mooring ships, as these berths have been discontinued;
- river cruise berth 4 is temporarily out of use due to renovation.

**Has decided the following:**

**I.**

It is prohibited for ships to berth at berths 4, 5 and 6 for river cruise ships at De Ruijterkade Oost, as indicated on illustration appendix 1.

**II.**

In order to implement the prohibition referred to under I., a sign has been placed on the jetties as stated in Appendix 7, A.5 (No berthing on the side of the waterway on which the sign is situated) of the BPR.

**V.**

This Decree enters into force one day after its publication.

This Decree will be published as an Announcement to Shipping IJmond North Sea Canal Area Central Nautical Management (BASIJN).

**VI.**

This Decree may be cited as 'Decree on mooring prohibition for river cruise berths 4, 5 and 6 located at Ruijterkade Oost'.

**Explanation:**

The municipality of Amsterdam has constructed a new ferry landing point west of the river cruise berths located at De Ruijterkade Oost. Due to the location of the new ferry landing point, river cruise berths (nos. 4,5 and 6) are not accessible to river cruise vessels. For this reason, river cruise berths 5 and 6 have been closed down.

River cruise berth 4 will be modified. Until this modification is complete, the berth is unavailable to

mooring ships. Following completion, the mooring prohibition will be lifted.

In accordance with the Algemene Wet Bestuursrecht (the Dutch General Administrative Law Act), an interested party can lodge a notice of objection against a decision within six weeks after its publication. The notice of objection must be addressed to: Burgemeester en Wethouders van Amsterdam, Postbus 202, 1000 AE Amsterdam. The notice of objection must be signed and must contain at least the name and address of the person lodging the objection, the date, a description of the Decision against which the objection has been lodged as well as the grounds for objection. If you choose to be represented, we request you to submit an authorization.

The notice of objection has no suspensive force. If, pending the objection procedure, the situation requires immediate relief, an application to grant suspension or provisional relief can be submitted to the judge in preliminary relief proceedings of the Rechtbank Amsterdam, Sector Bestuursrecht, afdeling lopende voorzieningen, Parnassusweg 226, Postbus 75850, 1070 AW Amsterdam.

Filing an application for provisional relief is subject to court fees.
